A. <u>Call to Order</u>

D. Executive Director's Report

Jack G. Lane, Executive Director

- The Governor released his budget last week; there was no additional appropriation for POST this fiscal year, but language was included in the budget that will allow POST to access fees. We have never done this before, although other boards in the state do access fees. POST staff is exploring options on how to undertake this process and what we need to do in order to access fees. POST will follow this as it goes through and continue to work on getting the budget stabilized. CJEF funding also has a big impact on the Arizona Prosecuting Attorneys' Advisory Council (APAAC); they are also funded 100% through CJEF.
- The Attorney General's Office recently settled a lawsuit and recouped \$780,000 from a pharmaceutical company. It is possible we may be receiving those monies to support Narcan Training for all law enforcement in the state. It would be a four year grant that will provide for training costs as well as equipping every officer with a dispenser to dispense the medication. This must still be approved by the Joint Legislative Budget Committee, but it is looking very promising that we will receive those funds.

E. Legislative Update

• Senate Bill (SB) 1072 is a new bill that was introduced that will allow someone that is not happy with an Administrative Law Judge's (ALJ) ruling to go to a superior court judge and receive a whole new hearing. This applies to all civil service board hearings in the state; as well as the types of hearings POST has before an ALJ. This creates a significant added expense for everyone and it will certainly burden the courts. POST staff needs direction from the Board on how to proceed; Executive Director Lane recommends opposing this. There was a discussion centered on the increased workload and expenses that will occur if this bill passes. Also, instead of opposing the bill perhaps staying neutral with concerns. Executive Director Lane will research this further and find out what is behind the need to make this very significant change and provide this information to the Board at next month's meeting.

G. Reports – Department of Corrections

Since the last regular meeting of November 2016, 57 cadets have graduated from COTA. There are currently four classes in session with 102 cadets in attendance. There are 830 vacancies statewide. Seven cadets have graduated through county and tribal detention IGAs. COTA continues to offer its facility to other agencies. Two applicants participated in the waiver process; for a savings of over \$13,430 to the agency.
